



ICE Out of CA Coalition 2019 Legislative Priorities

The ICE Out of CA Coalition is a network of more than 100 organizations working to disentangle local and state law enforcement from Department of Homeland Security (DHS) agencies to stop detention and deportation in California. The Coalition began in 2011 and since then has successfully organized and advocated for the passage of the TRUST Act (AB 4 - Ammiano) in 2014, the TRUTH Act (AB 2792 - Bonta) in 2016, and the CA Values Act (SB 54 - de Leon) in 2017.

This year, the coalition is prioritizing six pending California state bills based on their alignment with the Coalition's Policy Platform.

AB 392 (Weber): The California Act to Save Lives

Co-sponsored by ACLU of California, Alliance for Boys and Men of Color/PolicyLink, Anti Police-Terror Project, Black Lives Matter – California, California Faculty Association, Communities United for Restorative Youth Justice, California Families United 4 Justice, PICO California, Silicon Valley DeBug, STOP Coalition, UDW America – AFSCME Local 3930, and Youth Justice Coalition

- This bill would update California's use of force laws to ensure police officers avoid using deadly force at every possible opportunity.

AB 668 (Gonzalez)

Co-sponsored by California Applicants' Attorneys Association and Coalition for Humane Immigrant Rights of Los Angeles (CHIRLA)

- This bill would protect immigrants and all Californians from civil arrest at a courthouse when a person is attending a court proceeding or has legal business in the courthouse.

AB 1282 (Kalra): No Private ICE Act

Co-sponsored by Advancing Justice - CA, Freedom for Immigrants, and Legal Services for Prisoners with Children

- This bill would prohibit the California Department of Corrections and Rehabilitation (CDCR) from facilitating or allowing private security guards to detain, take custody of, or arrest individuals for immigration enforcement purposes.

AB 1332 (Bonta): The Sanctuary State Contracting and Investment Act

Co-sponsored by Secure Justice

- This bill builds upon SB 54 to prohibit a state or local agency from contracting with companies that provide a federal immigration agency with data brokering, vetting, or detention facility services.

AB 1747 (Gonzalez)

Author sponsored

- This bill would prohibit California law enforcement agencies from making their databases, including those maintained by private vendors, available for the purpose of immigration enforcement.

SB 136 (Wiener): One-Year Enhancement Repeal

Sponsored by ACLU of California, Californians United for a Responsible Budget, California Coalition for Women Prisoners, Coalition for Humane Immigrant Rights, Drug Policy Alliance, Ella Baker Center for Human Rights, Friends Committee on Legislation of California, Legal Services for Prisoners with Children, Pillars of the Community, Tides Advocacy

- This bill would repeal Penal Code § 667.5(b), a sentencing enhancement that adds an additional year of incarceration for each prior prison term or qualifying county jail term.
